## Paedophiles Liberation Front Manifesto

**(Author "THE SLURP" on line 1997/98)**

**Probably somebody said you that you can say no. Well, remember only one thing: if you can say no, you can also say yes.**

**If you feel to do something – you have the right to do it. It is you that may choose.**

**Sometimes the friends you have fun with may ask you not to tell others what you have done together. This often happens when your friends are adults.**

**The reason for this is simple: if people finds out that you have done something with an adult boy friend, or girl friend, they may put him or her in jail, and so destroy his or her life. Do you know what happens to you when people knows about this? You go to therapy.**

**Therapy means that you will be subject to someone who will try to convince you that all you have done with your friend is a horrible thing and your friend is a horrible person too.**

**They may also give you some drugs to make you stay calm. So you become a sick person.**

## Operation Cathedral 1997/ 98

**One of the Italian nationals arrested was subsequently found as being a reference point of the Italian editorial agency within the "pedophile ideology" website : "Danish pedophile Association" .**

**Several Italian subjects from the above-mentioned editorial agency assumed Danish nicknames and they declared themselves being pedophiles loving children.**

**Many investigations followed in the framework of the so called "cultural pedophilia" all representing great challenges sometimes concluded successfully.**

- Even if there is no intelligence to suggest that these subjects have been physically abusing children, what could we think about habits , opportunities and sharing about child abuse?

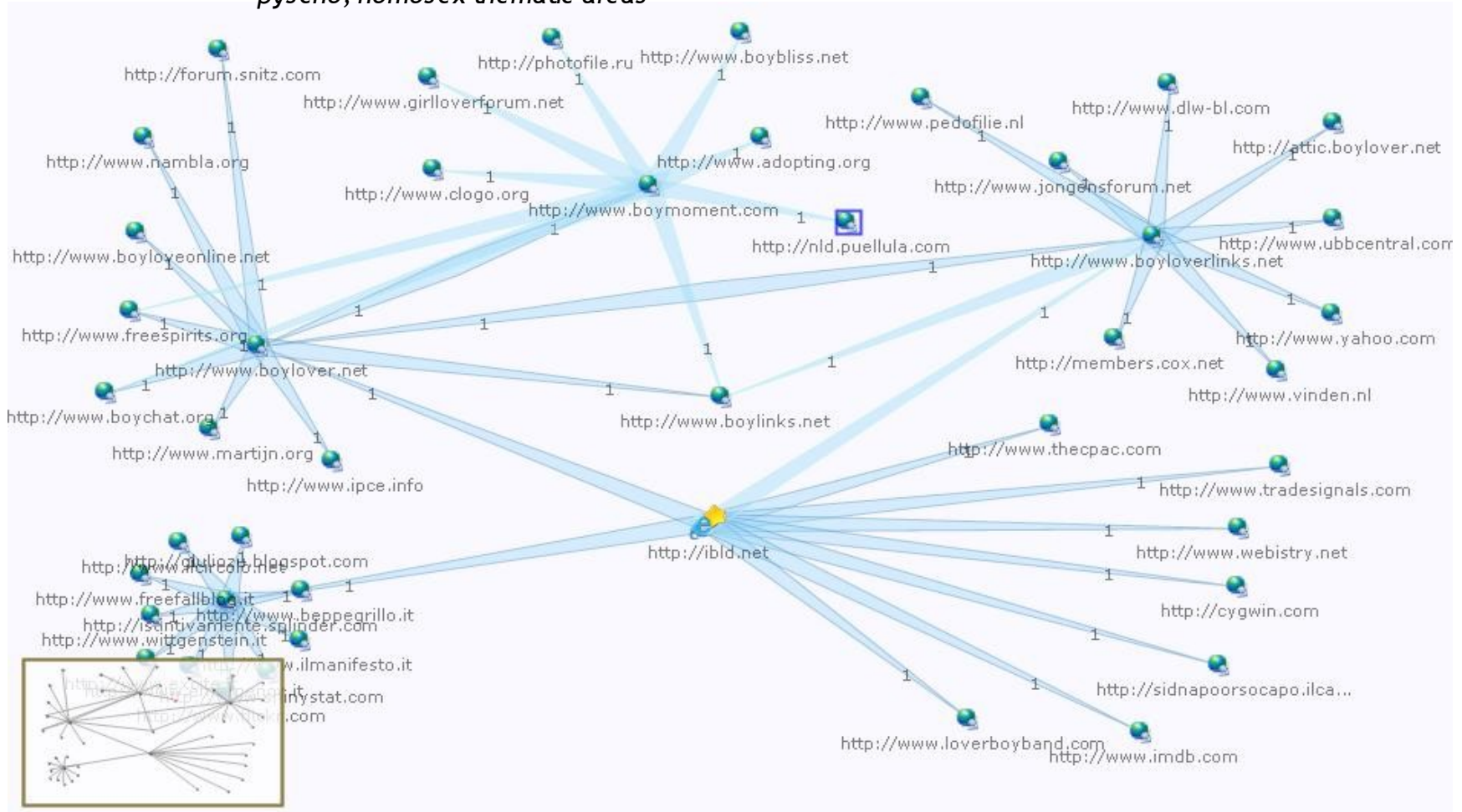

### DEFINITION AND CATEGORIES OF CHILD ABUSE MATERIAL :

Optional Protocol to the International Convention on the Rights of the Child (November 20 1989) on the trade of children, child prostitution, and child pornography, representing children at the United Nations. As far as concerns child abuse crime, it is defined as “every representation by whatsoever means of a child involved in explicit sexual activities, real or simulated or any representation of sexual organs of a child for purposes explicitly sexual;”



## DEFINITION AND CATEGORIES OF CHILD ABUSE MATERIAL :

- *Council of Europe Convention on the Protection of Children against Sexual Exploitation and Sexual Abuse - Lanzarote, 25.X.2007*
- **Article 20 – Offences concerning child pornography**
- **1 Each Party shall take the necessary legislative or other measures to ensure that the following intentional conduct, when committed without right, is criminalised:**



DEFINITION AND CATEGORIES OF CHILD ABUSE MATERIAL :

- a producing child pornography;
- b offering or making available child pornography;
- c distributing or transmitting child pornography;
- d procuring child pornography for oneself or for another person;
- e possessing child pornography;
- f knowingly obtaining access, through information and communication technologies, to child pornography.

2 *For the purpose of the present article, the term “child pornography” shall mean any material that visually depicts a child engaged in real or simulated sexually explicit conduct or any depiction of child’s sexual organs for primarily sexual purposes*



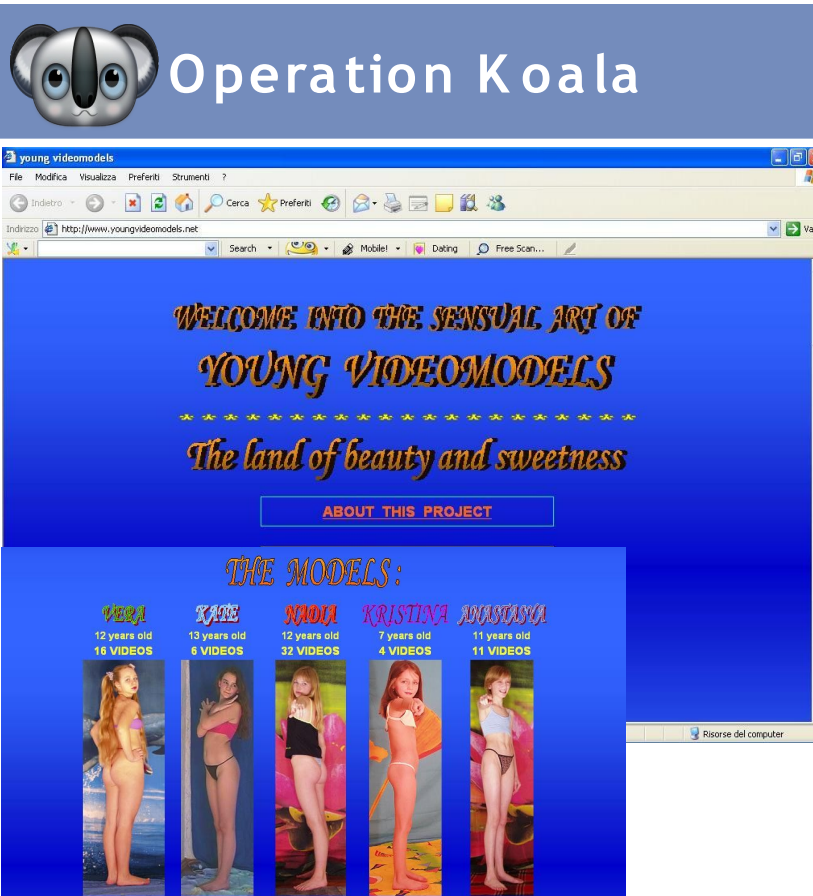
## Operation Koala



## Operation Koala

- July 2006: Child abuse video discovered by Australian police showing the rape of 2 young girls
- Offender and 2 victims, aged 9 and 11, identified in Belgium
- Producer of the video identified in Italy
- Italian national owns a website on which he sells child erotica and child abuse material
- Italian owns a studio in Ukraine





**Suspect also travels to Belgium and the Netherlands to produce video material**  
**Overall 150 videos lasting between 30 min. – 1 hour per video**  
**21 Ukrainian victims identified**  
**Customers from all over the world**  
**50,000 e-mails to and from customers recovered**  
**Data and video analysis at Europol**

## LAW 38/06

**Section . 14-quinquies. - ( Financial measures for combating commercial exploitation of child abuse material ). –**

**1. The Centre shall forward to the Italian Exchange Bureau (UIC), for further dissemination to banks and electronic payment companies, Poste Italiane S.p.A. and financial intermediaries providing for payment services, any information as under subsection 14-bis concerning those individuals receiving payments in relation to trading any child sexual exploitation material on the INTERNET or on other communication networks.**

## LAW 38/06

**2. Banks and electronic payment companies, Poste italiane Spa and financial intermediaries providing for payment services, shall notify the UIC all available information concerning any relationships and transactions associated with those individuals as identified under subsection 1.**

**3. For the purposes of this subsection as well as of subsection 14-bis the UIC shall provide the Centre with all information obtained under subsection 2.**

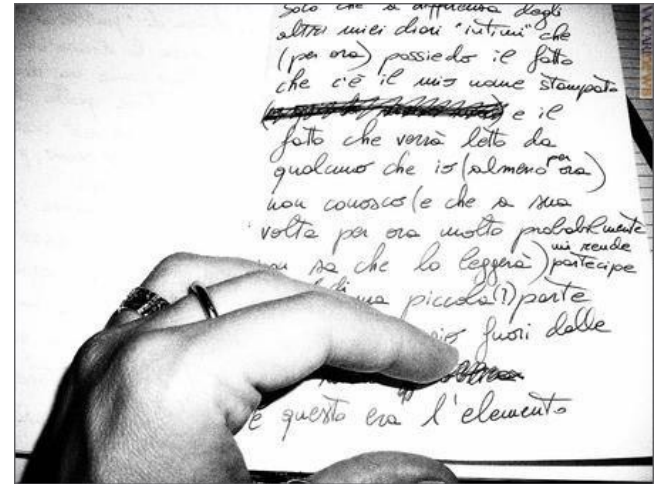
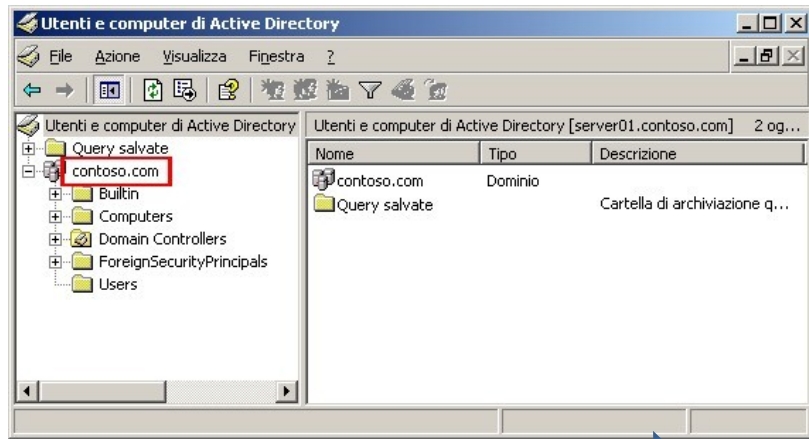
## LAW 38/06

**4. Any agreement between banks, electronic payment companies, Poste italiane Spa or financial intermediaries providing for payment services, and those individuals as mentioned in subsection 1 shall be cancelled and made ineffective, in relation to the use of payment cards by such individuals.**

**5. The Centre shall submit all information available concerning any payment card holder using a payment card for purchasing material related to child sexual exploitation on the INTERNET or other communication networks to the relevant bank, electronic payment company, Poste Italiane Spa, or financial intermediary issuing such payment card. They may also request the holder any possible information and subsequently cancel the holder authorisation to use payment card.**

## Law enforcement response

.....It is unrealistic, at this moment in time, to think that we can aim to completely prevent the sexual exploitation of children via the Internet. It is also unrealistic to attempt to remove all existing child abuse images from circulation. Emerging technology, combined with a lack of co-ordinated and united, world-wide international response, mean that these problems cannot readily be solved.

One strategy is aimed at disrupting child abuse offenders\* activity, and restricting access to Internet child abuse material.....

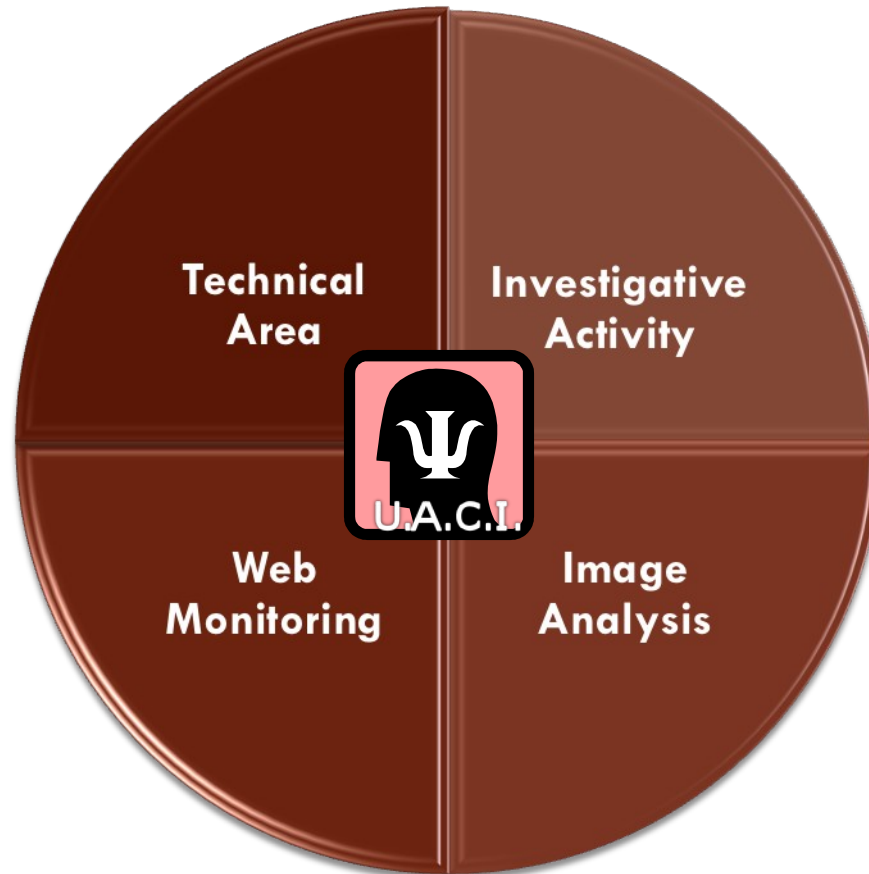
